## **ORDER**

As per the Government Order read above, Government have declared a Comprehensive II Policy for the State. The IT Policy envisages the establishment of an Institute of Excellence in Information Technology. Pursuant to the Policy declaration, KSIDC had undertaken a feasibility study to examine the scope and viability of establishing the School. Based on the feasibility study, the KSIDC has submitted a proposal for establishing a School for Information Technology and Management (SITMA) at the Technopark Campus, Thiruvananthapuram at an estimated cost of Rs.30 Crores

Government have examined the proposal in detail, and are pleased to approve the Project prepared by KSIDC for the establishment of School for Information Technology and Management (SITMA) at Technopark Campus, Thiruvananthapuram at an estimated cost of Rs.30 Crores—Orders on the funding pattern of the Project shall be issued separately.

The School will be an advanced centre of learning on the lines of the IITs and IIMs and shall offer a range of academic and non-academic programmes, such as, masters programmes in current Information technologies, short-term professional courses, incubator programmes to foster IT Entrepieneurs and Management of an Accreditation Programme to standardise IT training.

The School will be headed by a Professional Board of Governors and will have the requisite autonomy in its management and functioning. It will have quality faculty drawn from industry and academia. The day-today running of the Institute will be entrusted to a Director who shall be an eminent IT Professional. The School will have broad industry participation, particularly in course development and design, project consultancies and R&D Programmes

The School will be registered under section 25 of the Companies Act and the KSIDC shall act as a nodal agency for the purpose.

Government are also pleased to constitute an Empowered Committee for the operationalisation of the School with the following members.
