ORDER

As per the Order read as first paper above Government have accorded sanction for the establishment of an Integrated Service Centre (FRIENDS Janasevana Kendram) within Thiruvananthapuram corporation area as a pilot project for accepting utility bills / tax / fees etc pertaining to Land Revenue Department, Motor Vehicles Department, Civil Supplies Department, KSEB, KWA, Thiruvananthapuram Corporation and University of Kerala at a common place. The Centre started functioning at Saphalyam Complex, Palayam, Thiruvananthapuram from 29-8-2000. Subsequently Government had accorded sanction for the establishment of FRIENDS Janasevana Kendrams in other district headquarters on the model of Thiruvananthapuram project vide Government order read as second paper above and these centres have been functioning since March 2001.

2 With the view to extend the area of services of FRIENDS Janasevana Kendrams, Government are now pleased to approve the acceptance of telephone bills upto the pay by date in FRIENDS Janasevana Kendrams. This facility shall initially be introduced as a pilot phase in FRIENDS Janasevana Kendram, Thiruvananthapuram. Bharat Sanchar Nigam Ltd. (BSNL) shall pay a service charge @ Rs.6/- (Rupees Six only) per telephone bill accepted by FRIENDS centre. Sanction is also accorded for signing an MOU (Tripartite Agreement) between IT Department, BSNL, State Bank of Travancore and State Bank of India regarding the terms and conditions of the acceptance of the telephone bill payments.


