ORDER

Government had accorded sanction for the establishment of FRIENDS Janasevana Kendram in all the District Headquarters in the State for accepting utility bills / tax / fees etc pertaining to Land Revenue Department Motor Vehicles Department Civil Supplies Department KSEB, KWA, Local bodies and Universities concerned vide G O read as first paper above. As per G O read as second paper above sanction was accorded for accepting telephone bills up to pay by date in FRIENDS Janasevana Kendrams. Sanction was also accorded for signing an MOU (Tripartite Agreement) between IT Department, BSNL and State Bank of Travancore / State Bank of India regarding the terms and conditions of the acceptance of the telephone bill payments. It was also ordered that BSNL should pay a service charge @ Rs 6/- per telephone bill accepted by FRIENDS Centres.

Government are also pleased to approve the appended MOU to be signed with State Bank of Travancore / State Bank of India in this regard and authorise the Director Kerala Information Technology Services Society (KITSS) to execute the MOU on behalf of Secretary (IT).
