The Council of Ministers had approved the Strategic Implementation Plan for Modernising Government Programme in October 2002 published as G O read above

2 As the next step for the preparation of Detailed Implementation Plans on the basis of the Strategic Implementation Plans, five Sub Committees of the MGP Steering Committee chaired by the Chief Secretary were constituted, one for each of the five themes. After several sittings, four sub-committees have completed the preparation of background papers (referred to as Schematic Outlines) for the initiatives under their theme. The MGP Steering Committee approved 93 Schematic Outlines under four themes as detailed below and the papers were placed before the Council of Ministers for approval
