## ORDER

- 1. In the Government Order read above, Administrative Sanction has been accorded for permitting MGP Mission to Take 8000 square feet (approximate) office space on rent in the Rehabilitaion building of TRIDA near Medical College, Thiruvananthapuram at Rs. 6 50 per square foot and for carrying out furnishing including partitioning and Air-Conditioning required as per decision in the meeting of the MGP Empowered Committee held on 23/06/2003.
- The Secretary, MGP has negotiated with the officers of TRIDA and the Authority has as per letter read 2<sup>nd</sup> paper above conveyed its willingness for renting out 8078 sq.feet of office space in the above building as per the following conditions:-

1. Rent per square feet

Rs 6.5

2. Security Deposit

3 month's rent

As per the letter read 3<sup>rd</sup> paper above the offer of TRIDA was accepted by Government.

3 As per the letter dated 26/08/03 TRIDA has intimated that the Authority will Earryout the works detailed in the Annexure at an approximate cost of Rs. 6 lakhs on its own expense and sought execution of lease agreement in stamp paper and payment of following charges:-

1 One month's Rent
