## ORDER

As per Government Order read as first paper above Government Is a counted sanction for the replication of the AKSHAYA Project in all the districts in the Struct, except Malappurary District, commencing from 1.4.2004, in the letter read as a paper above, the Director KSITM has reported that one of the critical countries is the process of selecting suitable candidates as AKSHAYA entreprendure. As the number of applications are very large it is essential that a general selection critical is essential. He has therefore forwarded the following procedure for calection of entrepreneurs:

- a) Dissemination of forms in both online/offune modes.
- b) A common Application Form, which is to be followed through out the State.
- c) General Criteria for the selection of suitable entrepreneurs based on which the eligible applicants shall be ranked by Kerala State II Mission, for consideration of the Block Level Selection Committee.
- d) Block/Municipal/City Corporation Level Selection Committees shall be constituted with the following members:
  - 1. Block Panchayat President/ Municipal Chairperson/ Corporation Mayor Chairperson.
  - 2. Concerned Grama Pauchayath Presidents in the Block/Chairman of the Welfare Committee in the case of Urban LSGI's -Members.
  - 3. Representative of Load Bank of the area Member.
  - Representative of D!C/IEO Convener.
- e) Thereafter, the Block Level Selection Committee shall identify/select cligible applicants from the rank list, based on guidelines to be issued by the Kerala State IT Mission. Separate Interview Panels shall be constituted at each Block for considering/short listing prospective entrepreneurs. The short listed applicants shall be approved by a panel comprising District Penelmyat

President/Mayor (in the case of Corporations), Manager L. Chair in this Collector (Convener) Lead Bank Wasseger and General Manager Date.

- f) An amount of Rs.250/- will be collected as application processing for : . Ore time of initial EOP (5 thepreneurs Orientation Programme) from the applicants by Kerala State IT Mission.
- 15. The Director, Keraki State if Mission has requested Government to a writer the above selection procedure and to accord sanction to remit the rockip. This separate Bank Account maintained by Kerala State IT Mission exclusively for AKSHAYA.
- 3. After having examined the proposal, Government are pleased to approve the procedure as mentioned above for the selection of AKSHAYA entry, and a connection with the State Wide Roil-Out of AKSHAYA project. Covernment are obtained to accord sanction to operate/maintain a Bank Account in a managedizer. Bank in Thiruvananthapuram exclusively for AKSHAYA for the collisions are remittance of application fees and all other receipts for AKSHAYA, including corputation for connectivity, sanctioned vide G.O second cited. Separate registers are maintained for each item individually.
