ORDER

In the Government Orders read above, Government have accorded Administrative Sanction for implementing the District Level Connectivity for Video Conferencing Facility. Keltron submitted a proposal for providing Video Conferencing Facility in Secretariat & District Headquarters and five additional locations including Chief Secretary's Office, Advocate General's Office, Kerala House, Public Office and Vikas Bhavan at a total cost of Rs. 342.21 lakhs

- 2) The MGP Steering cum Empowered Committee has approved the proposal of Keltron for procurement of equipments and works for establishing video Conferencing Facility vide their minutes read as third paper above subject to the following conditions and with the concurrence of Planning & Finance Departments:
 - a) Being a State Agency and an approved Total Solutions Provider (TSP) of Government, the order may be placed directly with Keltron. Keltron will adhere to norms applicable to TSP.
 - b) Keltron will adopt open tendering for procurement of IT products and for site preparation.
 - c) The prices negotiated by Keltron with vendors will be further scrutinized and approved, after further negotiation if necessary, by a Committee consisting of a technical expert nominated by IT Department and a senior officer of Keltron.



- d) Keltron shall ensure that all items procured as well as the site preparation undertaken will have the necessary Performance Guarantee and Annual Maintenance Contract from the vendor/contractor.
- 3) Planning & Economic Affairs Department and Finance Department have agreed to the proposal.
- 4) Government have examined the proposal in detail and are pleased to accord Administrative Sanction to Keltron for the procurement of equipments and works for providing Video Conferencing Facility in Secretariat & District Headquarters and five additional locations including Chief Secretary's Office, Advocate General's Office, Kerala House, Public Office and Vikas Bhavan at a total cost of Rs. 342.21 lakhs <u>subject to the conditions specified above</u>. The expenditure to be met from the Head of Account "3451-00-101-82-Other items approved for implementation from Detailed Implementation Plans under MGP (Plan)".
