ORDER

The Department of Information Technology, Government of India have approved the project proposal for setting up of a State Wide Area Network (SWAN) for an estimated outlay of Rs. 78.70 crores spread over five years to be implemented by State Government designated implementation agency i.e. C-DAC vide letter read as 2nd paper above. As per G.O. read above, Government of Kerala have constituted a state level WAN Implementation committee for the Implementation of the State WAN Project in Kerala. In the meeting of the implementation committee of Kerala State WAN held on 18.02.2006, the implementation committee examined the detailed scope of work and the split up of cost given by C-DAC for consultancy, Project monitoring & SLA monitoring for the KSWAN project and approved the scope of work submitted by C-DAC. The cost of work is as follows:-

Cost for consultancy	: Rs 50 lakhs (to be paid after signing of agreement with the successful bidder)
Cost for Project Management	: Rs 200 lakhs (to be paid on commissioning of the project)
Cost for SLA Monitoring	: Rs 250 lakhs (Paid annually @ Rs 50 lakhs per annum after commissioning of project)

above costs submitted by C-DAC have been approved by the Department of Information Technology, Government of India and is part of estimated outlay of Rs 78.70 crores sanctioned by Department of Information Technology, Government of India vide letter read as 2nd paper above.

2) Based on the approval of proposal of C- DAC by the State WAN Implementation Committee, Government are pleased to approve C-DAC, Vellayambalam, Thiruvananthapuram as the "Consultant and Third party Agency" for the Kerala State WAN Project.
