ORDER

As per Government order read as 2^{nd} above Administrative sanction was issued for setting up of the Kerala Spatial Data Infrastructure(KSSDI). The KSDC can appoint the following additional members as and when required:

- 1. Maximum of 5 (five) Secretary rank officials of the Government of India or State Government departments whose activities are related to the KSDI.
- 2. Maximum of 5 (five) Experts having experience and qualifications in the fields related to Spatial Data - Geographical Information System (GIS), Remote Sensing, Digital Mapping, Photogrammetry, spatial and Non-spatial database. Information Technology, Networking, Software, Business Management, Law and other related fields.
- 3. Maximum of 5 (five) representatives from industry, academia and NGO's.

(i). Functions and powers

- (i) Formulate policies on all aspects, related to the KSDI, including its establishment, access and sharing pricing data based on National Map Policy and guidelines provided by NSDI.
- (ii) Frame rules and procedures for the conduct of the business of the KSDI.
- (iii) Decide and arbiter on issues relating to spatial data' generation and its availability in the state
- (iv) Promote open access to spatial data by citizen and develop spatial data services in public and private sector.
- (v) Promote and enable investment in the spatial business sector' and to create an environment that encourages competitive excellence;
- (vi) Promote the development of human resources in the spatial data sector by encouraging existing training institutes, universities, institutions offering specialized courses, etc to conduct training programs in Geo Spatial technologies:
- (vii) Promote advanced research related to the SDI activities and enable an ambience R & D for KSDI in the state;
- (viii) Aid and advise the Central/State Government on any matter related to, or connected with the Spatial Data;
 - (ix) Do all such acts and deeds that may be necessary, beneficial or otherwise desirable to achieve the objectives of the KSDI.
 - (x) Facilitate participation of data producing agencies for such purpose of sharing the data,

The Committee shall meet at such time and places as fixed by the Chairman.

In addition, the KSDC may appoint for a specified term, on recommendation of the Chairman of the KSDI Executive Committee, four (4) experts having experience and qualifications in the fields related to KSDI-Geographical Information System (GIS), Remote Sensing, Digital Mapping, Photogrammetry, spatial and Non-spatial Database. Information Technology, Networking, Software and other related fields can also be included.

Functions and powers of the Executive Committee

KSDI Executive Committee shall undertake any and all implementing and executive functions for and on behalf of the KSDC include

- 1. Determine the requirement of spatial data in the State and require creation or collection of spatial data to fill such requirement.
- To define and ensure implementation of standards for KSDI activities and to enable a smooth establishment and access to KSDI
- 3. To define and formulate rules and procedures for enabling NSDI databases servers, networks and access rules and filters
- To constitute technical, financial or other sub-committees to establish the KSDI and any other objectives and functions
- To define and formulate rules and procedures for enabling access to, databases, servers, networks and access rules and filters
- To aid and advise the NSDC on any matter related to or connected with its functions and the NSDI
- 7. To advise the KSDC on expanding the scope of KSDI by including newer-spatial and non-spatial data and agencies enabling a larger participation in KSDI To undertake activities to attract new entrants, private sector participation and stimulate innovation related to KSDI:
- 8. To encourage and set into operations value-added-services relating to the usage of KSDI for supporting developmental and economic activities; .
- Require any member, persons; entities or organizations to provide access to any data at such costs as may be reasonable;
- 10. Aid and advice the State Government on any matter related to or connected with the KSDI:

The Executive Committee will discharge all the implementing and executive functions for and on behalf of KSDC including the functions as may be prescribed by regulations framed by the KSDC.

Functions and powers

- a) Implement executive orders as per recommendations of the SDC/EC
- Formulate guidelines on. all aspects related to KSDI including its establishment, standards, access, and pricing etc.
- c) Identifying gaps in 'the database and, initiate, action for generation or, collection of data to fill such data gaps;
- d) Require any member, persons, entities or organizations to provide access to any data at such costs as may be reasonable;
- e) Creation of meta data repository (OGC standards) Finalization of Data security / encryption/ access mechanisms policy.
- Create and operationalize and ensure sustainability of State Geo-Portal
- g) Sensitize the concept of SDI and the utility of Geo-portal and clearing house in order to secure cooperation of different agencies in the development of KSDI.
- h) Undertake training programme to reach out the benefits of the Geoportal and the Clearing House.
- i) Provide continuity of the programme and monitoring of performance of various components of the program
- j) Monitoring of the service level available to various stakeholders
- k) To develop a web based Geo Portal to acquire, process, store, distribute and improve the utilization of geo spatial data (sharing of geo spatial data through internet) for planners, decision makers and public.
- 1) Monitoring Capacity Building and other training programmes envisaged for successful implementation KSDI
- m) Providing guidance and clarifications to the data providers and users
- n) Monthly review of project plans, and progress and advice the State Government on relevant matters.
- o) Determine the requirement, of spatial data in the State and require its creation or collection to fill such requirement;

- p) Aid and advice the State Government on any matter related to or connected with the KSDI:
- q) Enter into appropriate arrangement with any third party to undertake any specific activity connected with or related to any of the activities of the KSDI, including data generation, data assimilation, access, consulting, commercial exploitation of any data, etc.
- Do all such acts and deeds that may be necessary, beneficial or otherwise desirable to achieve the objectives of the KSDI.
