ORDER

During the financial year 2009-10 there is a total budget provision Rs.18,49,00,000/- to the KSITM under the Head of Account 3451-00-101-87 KSITM and also provision for ICT for under previleged sector and International Centre for Foss under the Heads of Account 2852-07-202-88 and 2852-07-202-91 respectively.

As per the Government Order read as second paper above Administrative Sanction was accorded for Ten Plan Schemes at an amount of Rs.724 lakhs under the Head of Account 3451-00-101-87 KSITM and Rs.150 lakhs under the Head of account 2852-07-202-91.

The Working Group met on 9.6.2009 discussed and approved the following plan schemes relating to KSITM:-

Government have examined the matter in detail and are pleased to issue Administrative Sanction for implementation of the schemes as follows:-

Administrative Sanction is accorded for the project at a cost of Rs.26 lakhs for making payment to C-DIT for application development and database and application server administration by meeting the expenditure from the budget allocation of Rs.10 lakhs under the Head of Account 3451-00-101-87 KSITM for the current financial year and the balance from the next year plan fund.

Administrative Sanction is accorded for the project at a cost of Rs.23 lakhs meeting the expenditure from reappropriation of Rs. 7 lakhs sanctioned for video conferencing and the balance from the amount Rs.25 lakhs earmarked for the project for the current financial year under the Head of Account 3451-00-101-87 KSITM



6. Irrigation SMS

Administrative Sanction is accorded for the project at a total cost of Rs. 2.20 lakhs meeting the expenditure from the funds provided under Mobile Governance Infrastructure under the Head of Account 3451-00-101-87 KSITM as follows:-

7. Voice Enabled Blood Bank.

Administrative Sanction is accorded for the project to be implemented through appropriate PPP model identified through RFP at a total cost Rs. 4 lakhs for the hardware, other communication Infrastructure and implementation cost meeting the expenditure from the funds left over during the previous year and carried over to current year for "ICT for Social Development and Research under the Head of Account 3451-00-101-87 KSITM.

8. Purchase of Laptops for IAS Probationers Training

Administrative Sanction is accorded for the purchase of 10 numbers of Laptop for IAS probationers training in the Institute of Management in Government (IMG) at a cost of Rs. 6 lakhs by meeting the expenditure from the Bridge Funding Scheme under the Head of Account 3451-00-101-87 KSITM during the current financial year and the amount will be released to IMG through KSITM.

9. M-Governance Infrastructure.

Administrative Sanction is accorded for the project at a cost of Rs.20 lakhs meeting the expenditure from the funds earmarked for Mobile Governance Infrastructure under the Head of Account 3451-00-101-87 KSITM for providing standardized web based SMS push interface for the Departments.

10. Automation of Certificates issued from Taluks in Kozhikode

Administrative Sanction is accorded for the project at a cost of Rs. 2,65,500/- meeting the expenditure from the Bridge Fund earmarked under the Head of Account 3451-00-101-87 KSITM during the current financial year for meeting the cost of the Automation of Certificates issued form Taluks in Kozhikode District. Administrative Sanction is accorded for the project at a cost of Rs. 7.5 lakhs for the installation of Kiosk and Self Guiding Digitized displays at Facilitation Centre meeting the expenditure from the Bridge Fund set apart under the Head of Account 3451-00-101-87 KSITM. The funds in this regard will be released to Thenmala Eco Tourism Promotion Society through KSITM.

Sanction is also accorded for the release of an amount of Rs. Rs.229 lakhs (Rupees Two hundred and twenty nine lakhs only) under the Head of Account 3451-00-101-87 KSITM Rs. 20 lakhs (Rupees Twenty lakhs only) under the Head of Account 2852-07-202-88 ICT and Rs. 5 lakhs (Rupees Five lakhs only) under the Head of Account 2852-07-202-87 to the Director, KSITM during the current financial year for the above project.
