ORDER

The DPR on SSDG prepared by KSITM, the nodal agency through M/S WIPRO as per the DIT guidelines has been forwarded to GOI for consideration. As per the DIT, GOI guidelines, after submission of Proposal and before the finalisation of RFP, the State/UTs have to formalise arrangement with the departments concerned, regarding processing of electronic requests received. This arrangement should lay down the respective duties and obligations of each entity in respect of each service proposed to be made available electronically as well as the service charges for the same and the apportionment thereof between the CSC/SCA and the other entities involved as may be decided by the state. This is a condition precedent to actual implementation. It is suggested that the above said commitment of participating departments may be solicited through aegis of the Apex Committee headed by the Chief Secretary.
