## <u>ORDER</u>

As per the Government order read above orders have been issued prescribing guidelines/ procedures for the implementation of e-Government procurement(eGP) project in the State. The proposed project is a comprehensive one, covering entire procurement process, i.e, right from pretendering process to post tendering process. The project is intended to be operated through a Private Implementation Partner (PIP) on BOO basis and the contract shall be awarded for a period of 5 years.

The Director, KSITM has released RFP for selection of the Private Implementation Partner and based on the Technical evaluation the following two bidders have been technically qualified.

(i) M/s. Tata Consultancy Services Ltd.(TCS), Trivandrum (Consortium Partner: Antares Systems Limited)

(ii) M/s. Hewlett Packard India Sales Pvt. Ltd. (HP), Bangalore.

The Director, KSITM vide letter read as 2nd paper above, has requested approval for the following:-

- (i) Approval of Pre-qualification and Technical bid evaluation process of e-GP project.
- (ii) Commercial bid opening of M/s. Tata Consultancy Services Ltd.(TCS) and M/s.

Hewlett Packard India Sales Pvt. Ltd. (HP), who are technically qualified.

In the meantime NIC has come up with a proposal for implementation of the e-Government procurement project for Kerala. The Technical Committee as well as the High Level Technical Committee examined the unified e-Government procurement solution for the State vis-à-vis the NIC solution and opined that NIC solution may not be feasible and unanimously recommended adoption of unified e-GP solution.

The Committee of Secretaries constituted as per GO read as 3<sup>rd</sup> paper above, has considered the recommendations of the Technical Committee and High Level Technical Committee and recommended to continue with the RFP process for implementation of the unified e-Government Procurement solution

in the State, initiated by Director, KSITM.

Government have examined the matter in detail and are pleased to approve the Pre-qualification a Technical bid evaluation process for identifying the Private Implementation Partner for e-GP project conducted by KSITM and also permission is granted for opening of the Commercial bids of M/s. Tata Consultancy Services Ltd.(TCS) and M/s. Hewlett Packard India Sales Pvt. Ltd. (HP). KSITM shall go on with the RFP process for implementation of the unified e-Government procurement solution in the State.
