As per GO read as II above Government of Kerala have issued administrative sanction for the project M/s KPMG was appointed as evaluating agency as per the guidelines issued by Government of India

KSITM invited tender for the appointment of an agency for design, site preparation, supply, installations, maintenance and operations of physical and IT infrastructure for the New State Data Centre. Director KSITM has reported that based on the prequalification evaluation report, technical evaluation the commercial bids of technically qualified bidders were opened.
