ORDER

As per the reference 1st cited the Department of Information Technology, Government of India have issued administrative approval for the new State Data Centre for the State of Kerala at a total estimated outlay of Rs. 55.68 Crores to be implemented through Kerala State IT Mission. The expenditure in this regard will be met through DIT contribution and ACA. As per G.O read as 2nd paper above, administrative sanction has been issued for the project. The project is being set up at Thejaswini Buildings in Technopark. As per GO read as 3rd above, the contract for undertaking the design, site preparation, supply, installation, maintenance and operation of physical and IT Infrastructure for the New Data Centre has been awarded to M/s. Sify Technologies at a cost of Rs. 22,49,93,049/-.

The Director, Kerala State ITMission has reported that the work on new State Data Centre at Technopark is progressing. In addition to the payment to the Data Centre Operator (DCO), funds are required to meet expenditure for preparation of site and installation and commissioning of extra high tension power supply at the Technopark premises.

During the Current Financial Year an amount of Rs. 2242/- lakhs has been set apart as ACA under Head of Account 3451-101-51 for the State Data Centre. But as per resumption of funds, vide G O 3rd above ,the amount comes to Rs.809 lakhs.
