**ORDER**

As per GO read as first paper above, Government had accorded Administrative Sanction for the deployment of State Portal (SP) and State Service Delivery Gateway(SSDG) in order to ensure the delivery of services to the citizens effectively and quickly. State Portal, SSDG projects aims at providing various Government services to the citizens near their doorsteps in electronic form. Many services offered by States under the State Portal are transactional in nature and require fees to be paid by the citizen for availing the services. Therefore it is necessary to integrate e-Payment services with the state portal. The integration of payment Gateway for enabling e-Payment will further facilitate the adoption of e-Governance and online request for Government services fulfilling the vision of NeGP. Under this circumstances DeitY, Government of India has set up payment gateway facilities for services offered by State Government or its departments through their respective portal. These payment facilities will enable any citizen/common service centre (CSC) / entity to make payments to DIT/State Government/Government of India and respective Government Departments/entities for services offered through the state/National portals or any other e-Payment initiatives/ channel, using either e-Card account or by debit to a designated bank account. Payment Gateway will enable transactions for all public/private banks in India through:-

- a) Credit Cards
- b) Debit Cards
- c) Online Banking
- d) Cash

The NSDL will charge transaction fee as given below for every transaction done through the payment gateway.

Sl.No.	Payment Type	Revised Fees (Excluding applicable Taxes)
1	Internet Payment	Rs. 5 per payment (for payments up to Rs. 500/-) Rs. 10 per payment (for payments from 500/- and above)
2	Debit Card Payment	Rs. 18 per payment for any amount
3	Credit Card Payment	1.00 % of the payment amount subject to minimum of Rs. 5 per payment

2. In this regard Department of Electronics & IT (DeitY) has entered into an agreement with NDML (NSDL Data Base Management Ltd), for providing a payment gateway integrated with state portal (SSDG). As per letter read as second paper above, DeitY, Government of India advised State Government to integrate their state portal and SSDG with the payment gateway operated and maintained by NDML.

3. As per letters read as third and fourth paper above, Head, SeMT and Director KSITM have recommended Government to enter into an agreement with NDML for integration of payment gateway with state portal/SSDG.

4. The Steering Committee on e-Governance headed by Chief Minister that met on 09-07-13 discussed the matter of integration of state portal into NDML payment gateway and advised Information Technology Department to go ahead with the proposal.

5. In this circumstances Government are pleased to accord sanction for integrating state portal/SSDG or e-Payment initiatives developed by State Government/Department with Payment Gateway facilities of DIT, Government of India set up by NDML. Director KSITM is authorized to enter into an agreement with NDML subject to the following condition:

- i. There shall be no expenditure for the State Government and no post creation consequent to the integration of state portal with NDML Payment Gateway.
