ORDER

As per Government Order read as first paper above orders have been issued to implement "e-Office" of National Informatics Centre for file processing in all departments in the Government Secretariat by entrusting the entire task of implementation with National Informatics Centre (NIC). As per Government Order read as second paper a Committee headed by the Chief Secretary has been constituted for monitoring the implementation of " e-Office" in all departments in the Secretariat.

As per letter read as 3rd and 5th paper above, the Director, KSITM has reported to Government that as per the project report of National Informatics Centre, the implementation of "e-Office" Project require an amount of Rs 300 lakhs for the year 2013-14 and that the amount required for the above project can be met from the savings available from various heads of accounts of projects under KSITM.

Government have examined the matter in detail and are pleased to accord Administrative Sanction for the implementation of "e-Office" Project in the Government Secretariat at a total cost of Rs. 300 lakhs (Rupees Three hundred lakhs only) in the
