ORDER

As per G O read as 1st paper above an Empowered Committee was constituted with Chief Secretary as Chairman to ensure time bound implementation and for sorting out issues pertaining to e-governance. As per G O read as 2nd paper above an Apex Committee was also constituted as envisaged in the guidelines for implementation of SSDG as part of NeGP, under DeitY, Government of India

2 Various e-Governance projects are being planned and implemented by state Government departments. State of Kerala have already made significant advancement in implementing a number of e-Governance initiatives such as SSDG, Service Plus, e-District, e-Office, e-Procurement, in Governance etc. At present each e-Governance project is monitored and guided by a committee setup exclusively for individual projects and majority of the committees are chaired by Chief Secretary. Now it is felt that a common single Apex Committee headed by Chief Secretary with Secretaries of actively participating departments in e-Governance as members would be ideal for overall guidance, monitoring and sorting out issues pertaining to all e-Governance initiatives.

3 The Apex Committee on SSDG/Empowered Committee on e-Governance that met on 26-12-13 decided interalia to constitute a single Apex Committee chaired by Chief Secretary and consisting of Secretaries/Head of Departments

that make significant advancement in e-Governance initiatives by replacing all other existing Apex Committees/Empowered Committees/State Project Committees constituted for various e-Governance initiatives.

4 In the circumstances, Government are pleased to constitute an Apex Committee for e-Governance initiatives with Chief Secretary as chairman for overall guidance and monitoring. This committee shall ensure time bound implementation and also sort out issues pertaining to all e-Governance initiatives of the state. This apex committee shall replace all other higher level committees which had been constituted for various e-Governance initiatives, at state level.

5 The structure of the committee shall be as follows:


