#### ORDER

Government of India have approved the National e-Governance Plan (NeGP) with a vision of making all Government Services accessible to the common man in his locality through Common Service Centers (CSCs)/Internet with more efficiency, transparency and reliability of such services at affordable costs. e-District project is one of the 27 Mission Mode Projects (MMP) of NeGP under Department of IT, Government of India.

- 2. The Districts are the primary delivery channels for Government Administration to deliver a large number of services to the citizens and the e-District project aims to target high volume service delivered at the District level through Akshaya/Web portal. Government of Kerala has nominated Kerala State IT Mission (KSITM) as the State Designated Agency (SDA) for the implementation of e-District project in the State. The project will optimally utilize State Data Center (SDC) and Kerala State Wide Area Network (KSWAN).
- 3. As per Administrative approval read as first paper above, Government of India has sanctioned Pilot e-District project for two districts, Kannur and Palakkad at a total cost of Rs 599.01 Lakhs. Subsequently State Government as per G.O read as second paper above constituted a State Project Committee headed by Chief Secretary, State Level Technical Committee headed by Director, KSITM and District level Committees in Kannur and Palakkad for overseeing and smooth implementation of the e-District project. 23 services of Revenue Department have been made online under e-district pilot project.

4. Kerala Information Technology (EDS) Rules 2010 issued under the GO read as 3<sup>rd</sup> paper above impowers Government to carryout electronic delivery of services under the e-District project and 23 Revenue services have been specified as 'e-services'. With the successful implementation of pilot project, Detailed Project Report (DPR) for statewide rollout of e-District project at an estimated cost of Rs. 7078 lakhs was submitted to Government of India for approval, as per Government letter read as 4<sup>th</sup> paper above. In turn Government of India as per Administrative approval read as 5<sup>th</sup> paper have accorded Rs 3389.26 lakhs for the Statewide roll out of e-District Project in Kerala and subsequently enhanced the total outlay to Rs.3428.12 Lakhs with Central share as Grant in Aid of Rs.2568.12 lakh and ACA share of Rs 860 lakh to be implemented over a period of four years as per administrative approval read as 10<sup>th</sup> paper above. Rs. 25,68,12,000(GIA) will be given by DeitY, Government of India directly to KSITM and the remaining amount of Rs. 8,60,00,000 (ACA) will be provided to Government of Kerala under the ACA share. The break up details of funding pattern of e-District statewide rollout as approved by DeitY(Department of Electronics and Information Technology) is given below:

5. Additional Central Assistance share is earmarked for the purpose of Site preparation and Data Digitization only. Since the state has almost completed the data digitization and the minimal requirement of site preparation cost the Director, KSITM has proposed to revise project outlay in line with the actual requirement level for the Government of Kerala. The breakup of the revised project outlay under the ACA share is as given below:

- 6. In accordance with the Government of India guidelines, State Government as per G.O read as sixth paper above had constituted District e-Governance Societies for the statewide rollout of the project. The Steering Committee meeting headed by Chief Minister held on 9.7.2013 as per minutes read as 7<sup>th</sup> paper above has decided, inter alia, to roll out more services under e-District in the State. Accordingly Government as per G.O read as eight paper above has decided to incorporate the following services under e-district project, in addition to existing 23 services, subject to the formal amendment in Kerala IT(EDS) Rules 2010.
  - 1. Minority Certificate of Revenue Department
  - 2. RTI Application of all departments
  - 3. Public Grievances application of all departments
- 7. State of Kerala has also launched e-district public portal so as to enable the public to avail the online services offered under e-District, by paying applicable service charges. As per G.O read as 12<sup>th</sup> paper above, port folio of e-District services originally envisaged in the DPR has been revised and are listed as Annexure to this order.
- 8. As per letter read as 9<sup>th</sup> paper above, Director, KSITM has requested to accord Administrative sanction for the ACA share of Rs 860 lakhs for the purpose as detailed in the table at Para 5 above and to release the necessary funds at the earliest. As per Office Memorandum read as 11<sup>th</sup> and 14<sup>th</sup> papers above, Government of India has informed that DeitY has already released 1<sup>st</sup> and 2<sup>nd</sup> instalment of GIA of Rs. 516.65 lakhs to KSITM and released an amount of Rs. 401 lakhs as first instalment of ACA to the State Government against e-District project. Hence the total amount released so far comes to Rs. 917.65 Lakhs. Rs. 401 lakhs has been credited to State Government account on 26-03-14 vide RBI clearance memo number: 21. As per Addendum-Administrative Approval read as 14<sup>th</sup> paper above, Government of India has now informed that the balance amount of Rs. 2510.47 Lakhs [3428.12-917.65] under the project has now become payable as part of restructured centrally sponsored scheme(CSS) called NeGAP

and the amount would be released from the Budget provision of Government of India under the Major Heads "3601-Grants-in-Aid to State Government. The special working group that met on 04-06-14 (as per minutes read as 13<sup>th</sup> paper above) had approved the e-District state wide rollout (CSS) project, at a total cost of Rs. 34.28 Crores.

- 9. Government have examined the matter in detail and are pleased to accord Administrative Sanction for implementing e-District project in Kerala (State Wide Roll Out) at a total outlay of Rs.34,28,12,000(Thirty Four Crores and Twenty Eight Lakhs and Tweleve Thousand only) with revised portfolio of services appended at Annexure-1 subject to the satisfaction of guidelines issued by Government of India/state Government from time to time in this regard, and specific condition given below:
  - i) Release of fund will be based on sanction/approval from Government of India.
  - ii) The expenditure would be met from the provision available under the appropraite Head of Account.
  - iii) The fund release will be based on actual requirement and the fund released should not be parked in banks.
  - iv) Store Purchase Rules shall be strictly adhered to
  - v) Tender/e-Tender and other stipulated formalities shall be followed whereever necessary.
  - vi) For civil works, CPWD rates shall be followed from 01-10-13.
  - vii) Post creation and purchase of vehicle are not admissible under the scheme.
  - viii) KSITM will be the implementing agency of the e-District project.

The expenditure in this regard shall be met from the Head of Account 3451-101-99-01-1(40).
