ORDER

Government vide Order read as first paper above have approved the Subsidy Manual for the disbursement of incentives to eligible IT units under the scheme IPMC (Investment Promotion and Management Cell). An amount of Rs.300 Lakhs had been sanctioned vide Government Order read as second paper above for the scheme during the current financial year (2014-15) subject to the condition that " the amount 300 Lakhs sanctioned for Investment Promotion Management Cell (IPMC) (Item No.8 under para 1) shall be handed over to District Industries Centres (DICs) for implementation with pending applications" The Director, KSITM in his letter read as third paper above has informed that multiple applications have been processed during the current financial year and applications are being submitted by units via the online system also and hence to issue necessary instruction regarding the process to be adopted in the light of new direction so that pending applications of entrepreneurs which are under process are not delayed once approved by the co-ordinating officers.

2. Government examined the matter in detail and have decided to rescind the condition stipulated at para 2.10 of the Government Order read as second paper above to transfer the scheme to Industries Department since it contravenes the conditions in the Subsidy Manual for the scheme. The Scheme will be implemented by the IT Department themselves following the extant guidelines stipulated in the Government Order read as 1st paper above.

3. The Government Order 2nd read above stands modified to that extent.
