ORDER

The State Data Centre (SDC) is one of the critical Information Communication Technology (ICT) Infrastructure of the State which hosts websites/Applications of Government of Kerala and holds critical information of the State. For Safe Preservation of the critical data in the SDC, Disaster Recovery Centres which replicates Data at SDC needs to be setup. As part of National e-Governance Plan (NeGP), Government of India have allocated NIC Disaster Recovery Centre at New Delhi as the Disaster Recovery(DR) site for Government of Kerala. In order to start Data Transfer, connectivity from SDC and DR site needs to be established.

The Director, KSITM as per the letter cited above have furnished specific proposals for establishing connectivity from SDC to DR site. As per the proposal an amount of Rs. 37,38,804/- (Rupees Thirty Seven Lakhs Thirty Eight Thousand Eighty. Hundred and Four only) is required for SDC-1 and Rs. 99,87,880/- (Rupees Ninety Nine Lakhs Eighty Seven Thousand Eight Hundred and Eighty only) is required for SDC -2, as detailed below. For SDC-2 the entire amount is funded by Government of India.
