ORDER

As per Government Order read above an APEX Committee for e-Governance initiatives with Chief Secretary as Chairman had been constituted. The APEX Committee on e-Governance in its meeting held on 16.7.2015 had taken following decisions pertaining to SSDG (State Service Delivery Gateway).

SSDG (State Service Delivery Gateway)

- (a) i) The Registration Department shall procure a valid SSL(Secure Sockets Layer) certificate for integrating with SSDG.
 - ii) The Motor Vehicles Department shall settle the mode of remittence of service charge collected by them with Finance Department within one month. The integration of services of MVD with SSDG should be immediately carried out after settling the above.
 - iii) The Commercial Taxes Department shall integrate all their services with SSDG(State Portal) with immediate effect.
- (b) i) All Departments should invariably integrate or provide link of e-Services rendered by them to the SSDG Portal so that public can access to all State Government services under one umbrella.
 - ii) All Departments shall furnish information and e-services to be shared with KSITM in a prescribed format for uploading the same in the State Portal. The KSITM shall prepare the format in consultation with Tata Consultancy Services and C-DIT.
- (c) Proposals from any Government Departments/Agencies for new e-Governance applications shall be entertained only through facilities offered by the IT Department such as SDC, KSWAN & common e-Governance applications like SSDG, e-District, Service Plus.etc. Therefore Departments shall not purchase servers and other hardwares or to start new e-Governance applications etc in the light of common infrastructre facilities and e-governance applications already available. All Departments shall strictly adhere to the above direction.

Government are pleased to accept and approve the above decisions of the APEX Committee on e-Governance held on 16.7.2015.
