ORDER

The Director, Akshaya as per letter read above has forwarded a proposal for the approval of new Akshaya Centres in Ernakulam District on the basis of the recommendation of the District e-Governance Society and resolution from the concerned Local Self Government Institutions.

Government have examined the proposal in detail and are pleased to accord sanction to start new Akshaya Centres in Ernakulam District as enlisted in the annexure to this order, subject to the following conditions.

- 1) the maximum limit of Akshaya Centres in the Panchayat area shall be 4 numbers. In municipality area it shall be 6 numbers.
- 2) The number of Akshaya Centres in Corporation area shall be decided on the basis of the density of house holds and on the basis of request from the corporation.
- 3) The distance between two Akshaya Centres shall be maintained as 2 Kilometers.
