### ORDER

The Apex Committee on e-Governance constituted as per GO read above in its meeting held on 24-02-15 had taken decisions pertaining to various e-Governance initiatives.

The Government are pleased to accept and approve the following decisions of Apex Committee on eGovernance held on 24.2.2015.

#### I. Aadhaar

- a) e-KYC (Know your citizen) of Aadhaar shall be treated as the common infrastructure for the State and the information shall be made available to all the departments to utilize the services for Aadhaar enablement.
- b) All the Citizen Centric Departments shall start seeding their Database with Aadhaar by using SRDH(State Resident Data Hub) database
- c) All the departments shall take Aadhaar related software support/ authentication services setup by KSITM for State instead of paid service of private institutions
- d) To include Aadhaar number in all application forms as a non-mandatory field.

## II. Service Plus

a) The services of Excise Department shall be launched through Service Plus. The existing projects like SSDG & e-District shall also be leveraged for implementation of electronic service delivery.

#### III. eDistrict

- a) The procurement of 1,500 laptops/Desktops shall be done for the use of Revenue Department at a cost of Rs.550 Lakhs subject to implementation of the following services in each revenue district.
  - Online Pokku Varavu
  - 2. Online Tax payment
  - 3. Online Nalvazhi
  - 4. Revenue Court Cases
- b) Adequate transaction funds shall be given to all District e-Governance Society every 6 months, upon receiving Utilization Certificate, Subject to implementation of the following services in each district by Revenue Department.

- 1. Online Pokku Varavu
- 2. Online Tax payment
- 3. Online Nalvazhi
- 4. Revenue Court Cases
- c) The procurement of Multifunctional Printers for 1446 Village/Taluk/RD Offices for PG/Revenue court cases shall be done at a cost of Rs.180 Lakhs, subject to implementation of the following services in each revenue district.
  - 1. Online Pokku Varavu
  - 2. Online Tax payment
  - 3. Online Nalvazhi
  - 4. Revenue Court Cases
- d) Broadband connectivity provided by BSNL or Railtel shall be given to all Village Office in the State in place of existing VPN connectivity.

## IV. Kerala Spatial Data Infrastructure (KSDI)

a) The Geospatial data collected by all Departments/Government agencies shall mandatorily be shared with Kerala Spatial Data Infrastructure in appropriate format as prescribed by KSDI. The KSDI shall inturn share the so collected geospatial data with all Government Departments/Government Agencies for their use in enhancing their decision support system after verifying the necessity.

# V. Aadhaar based bio metric Attendance System

a) Aadhaar based biometric attendance system shall be done as pilot initiative in Kerala State IT Mission. This shall be replicated in other departments/offices after the successfull implementation of the same in KSITM.

The Director, Kerala State IT Mission is appointed as the nodal officer for co-ordinating with Departments/Government Agencies for implementing the above decisions. He shall take appropriate action by setting specific time limits.
