ORDER

As per Government Order read above an APEX Committee for e-Governance initiatives with Chief Secretary as Chairman had been constituted. The Committee in its meeting held on 16.07.2015 had inter alia taken following decisions pertaining to the e-Governance initiatives.

KSWAN (Kerala State Wide Area Network)

- a) All Government Department shall facilitate necessary space & power with UPS backup to the network equipments of KSWAN, being the the common Infrastructure maintained by Government.
- b) All Departments shall make use of Helpdesk facility of KSWAN (Toll free - 1800 425 6171) for reporting their complaint.

NOFN (National Optical Fibre Network)

- a) LSGD shall take action for providing FTTH (Fibre to the Home) services at Grama/Block Panchayat level using NOFN, which shall be used instead of existing BSNL broadband
- b) Public Wi-Fi Hotspots shall be provided in rural areas leveraging NOFN.
- c) All Departments shall extend OFC from the NOFN point to the last mile Government institutions through KSEB, BSNL or any other agencies only with the prior approval of IT Department / KSITM.
