Subsequently, as per G.O read as second paper above, the above e-Procurement slab had been made applicable to all tenders above Rupees Five lakhs.

- 2. The Cochin University of Science and Technology (CUSAT), as per letter read as third paper above, has requested to clarify whether the Government orders read above are applicable to the tenders floated by Autonomous Body like Universities.
- 3. Government have examined the matter in detail and wish to clarify that e-procurement system introduced in Government Departments, Public Sector undertakings and Boards as per Government Orders read above shall be applicable to all Autonomous Bodies (including Universities)

and Constitutional Bodies in the State, where such government directions had been made applicable earlier.
